

Waste Management

Ways to Keep Marina Waters Clean & Healthy

Separate trash from recyclables.

Use leak proof trash bins with tight lids.

Install a pumpout.

Set up a fish cleaning station away from the water.

Do not dispose of fish waste in marina basin.

Assign a boat work area equipped with a spray booth.

Use non-toxic cleaners and paints.

Filter run-off by planting a vegetative buffer strip.

Keep catch basins clean.

Don't top off fuel tanks.

Report spills.
